Dear Ambassador Margaryan and Ms. Mlambo-Ngucka,

On behalf of sixty-six* civil society organizations, we are writing to share our recommendations with regard to civil society participation in the 65th Session of the Commission on the Status of Women.

As you know, the CSW has traditionally been the largest annual global gathering on gender equality and women's, adolescent girls' and girls' human rights and is an important space not just for shaping global norms and standards on these issues, but in building solidarity between different stakeholders and strengthening feminist and women's rights movements. We value deeply the role that the Commission plays in advancing global commitments on women's, adolescent girls' and girls' human rights. We know that robust engagement from feminist and gender justice organizations and movement has been a key driver in that progress, precisely because of our unique role in both advocating with governments to be bold and ambitious and holding them to account. Yet, we have also seen how the trend of closing of civic space at the country level and the global level, including at the CSW, has undermined our influence and jeopardized our work. For many of us, COVID-19 has accelerated this trend. CSW65 is an opportunity to reverse course and once and for all place feminist and gender justice organizations at the center of our collective work to advance gender equality and realize women's, adolescents and girls' human rights.

As you plan for CSW65, we ask that you consider the following:

- Establish a task force with regionally diverse feminist and gender justice organizations to identify and select civil society speakers for all official plenary sessions and panels. In doing so, we would suggest using regional processes with respective UN economic and social commissions as a mechanism for collating recommendations for civil society speakers.
- Establish the practice of giving equal space to governments and civil society. Alternate
 government and civil society speakers in plenary and panel sessions to allow for an

- exchange of diverse views and foster greater opportunities for interaction and meaningful engagement.
- Establish mechanisms for the virtual participation of government and civil society representatives on official delegations in the negotiation of the Agreed Conclusions and other resolutions under consideration, from the first reading. As you know, it has been a struggle to engage delegates from Capitals in negotiations that typically take place before the CSW starts; this is an opportunity to shift that dynamic and establish a new best practice to enable their early and active participation. In doing so, the time difference must be taken into account to create an enabling environment, especially for those located in the global South to actively and meaningfully participate.
- Ensure that all CSW online forums and spaces are inclusive, accessible and feminist in design; they should include reasonable accommodations for people with disabilities, and multi language interpretation, ensuring the robust participation of women from the global South, grassroots movements, and those who have historically been on the margins of civic space.
- Work with UN Women country offices to help to bridge the digital divide and facilitate
 access to technology and create other opportunities (for example, by opening UN
 Women offices to advocates, with respect for COVID-related precautions) to ensure
 diverse participation by women, girls and gender justice advocates, including those living
 in rural areas, people with disabilities, indigenous communities and others who
 experience marginalization or discrimination.
- Allow negotiations to be observed by registered civil society organizations and consider opportunities for comment, in a similar way to negotiations on political declarations for the HLPF.

We have never had a virtual CSW before, but in this new era, it likely will not be the last. We have an opportunity before us to broaden participation, especially for those facing financial and visa-related obstacles for traveling to New York, including intersectional feminist activists, women human rights defenders and organizations from the global South, and to develop new best practices for engaging civil society and representatives from capitals. This would ensure that the Commission continues to be an inclusive, inspiring and relevant space.

We would also urge the Bureau, along with ECOSOC, to consider this as an opportunity to reopen discussions about the future of the CSW and its working methods to ensure more robust civil society and global South engagement moving forward, for example by creating or making space for a civil society seat on the Bureau and in decision-making related to the CSW or enabling virtual participation on an ongoing basis.

We stand by to assist you with this critical task.
